# Homestead Co-op raises \$10K on

Homestead Co-op donated almost \$10,000 to three local charities thanks to Fuel Good Day.

Fuel Good Day is an annual event that started in 2017. Co-ops across western Canada donate a minimum of five cents per every litre of gas sold on one specific day to a charity or organization of their choice. Homestead Co-op chose Wee Care Child Center, the North Norfolk Active Transportation Committee, and four educational and recreational programs in Portage la Prairie for this year's recipients. This year's Fuel Good Day was on Sept. 21, and Homestead Co-op donated 10 cents per every litre of gas sold then. They raised a total of \$9,999, allocating \$3,333 to each of the orga-


#### **VOLUNTEERS**

We are so fortunate that so many people volunteer their time to help make SCA events and programming successful. Although we were not able to hold our usual planned events, several people volunteered to help out with our summer Day Camps, and our Co-op Week events, and our Co-op Merit Awards Committee also contributed their time in 2021. Thank you to everyone that helped us out in 2021!



#### FINANCIAL STABILITY

With the limitations on programming events caused by the pandemic, our ability to generate non-dues revenue was limited compared to other years, as can be seen in Chart 1 and Chart 2. Staff worked hard to contain costs during the year, but we did incur a loss by year end. We repaid our CEBA loan in 2021-22, and took advantage, temporarily, of a few other federal government COVID support funds for organizations. Thankfully, our members, sponsors, donors and supporters continued to invest in SCA and we were able to deliver some of our programming this year. We reinvested some funds that we had cashed out of our investments in 2020 (Chart 3), and with the overall year end loss, our retained earnings have reduced from the prior year (Chart 4).





Chart 3. Value of SCA Investments




Chart 4. SCA Retained Surplus

# YOUTH ENGAGEMENT

# & INVOLVEMENT

2021-2022 was again a year full of surprises for the Saskatchewan Co-operative Youth Program (SCYP). We began our year in April again facing a continuing public health crisis. Faced with another year of being unable to host our overnight camps, but being allowed to have gatherings of people, we decided to modify our programming and combine it with our promotional strategy of going into schools. This created the Saskatchewan Co-operative Travelling Road Show.

The Road Show was a day camp that served over 100 youth in 17 communities across Saskatchewan. We traveled over 5500 kilometers in 6 weeks. We now have 44,596 participants and alumni of the program!


#### **PARTICIPANTS**

The kids who we met in the 17 communities were a wide range of youth, ranging from 12 to 18 years old. We did not divide the youth into the usual camp levels, rather we worked as co-operatively as we could and we did tasks and projects from all levels of the program. There were no participants who self-identified as either an Indigenous person or a member of a Visible Minority. We had both new to the program youth and returning campers who were familiar with our programming.

Parents of the participants were happy with the option to have some form of Co-op Camp during the summer. 100% of the parents who returned a post-camp survey were extremely satisfied with both the materials that were presented and the value of the program for the money they spent. The majority of participants (60%) resided in small municipalities while 40% were urban youth from communities with populations over 5,000.


















#### **STAFF**

Since we were unable to continue with the regular inperson camps, we did not require our regular alumni and sector volunteers that we require to run the in-person summer camps. We truly missed our alumni and the sector volunteers and are very eager to have them return to camp for summer 2022.

# SPONSORSHIP AND ADDITIONAL REVENUE

The Co-operators staff were able to run a small fundraiser for the SCYP, even though they were mostly working from home and were not gathered in their offices. They truly understand the value of the youth program and they raised \$640! We truly thank the dedicated employees from Co-operators, who are SCYP champions, for their ongoing support.

Thank you to Federated Cooperatives Limited for allowing us to redirect the camp bursary funds they provided in 2021 to help offset the costs of

developing and delivering our Day Camp programming. In 2021 the Program Assistant wage was partially offset by a federal government summer student wage subsidy.

In 2018, a multi-year sponsorship deal was made with Innovation Credit Union to celebrate and honour Earl Hanson, a long-time co-operative leader in his community, and Graduate Camp was renamed the Innovation Credit Union Earl Hanson Graduate Camp. Even though we were unable to hold the week-long camp during the summer of 2021, Innovation still made the \$2,000 donation to the Camp program. Thank you so very much to the team at Innovation Credit Union!

Federated Co-operatives Limited also allowed us to keep their Week Sponsorship funds in 2021 and redirect those funds to our 2021 youth day camps. Thank you so much to Federated Co-operatives for recognizing the value in our work with Saskatchewan's young people!

# PROMOTIONS AND COMMUNICATIONS

Normally, we develop a theme that we use to promote camps and we build marketing around this for our summer camps. We chose to simply promote the summer of 2021 as the Saskatchewan Co-operative Travelling Road Show. We focused on promoting the co-operative values that make our sector so fantastic. The promotional strategy for SCYP 2021 was very similar to the methods we used in 2020. We were unable to enter schools to do our presentations, or attend in-person events with youth, we focused heavily on the social media and online presence that we have been building for the last few seasons.

SCYP continues to have a large online presence. SCYP social media promoted the day camps in May and June with Facebook Ads and continued posting activity on Facebook, Twitter, Instagram, and YouTube. Since the winter of 2019 we have been researching and developing a new look and brand for the camp program. While our camp program has been around in one version or another since 1928, there have been only a few major changes to the look and feel of the programming.

# CAMP KINDLING LAUNCHED

During Co-op Week, we officially launched the new look and name for the youth program: Camp Kindling Co-operative Youth Retreat. With the new name and logo, we also prepared a new marketing strategy for the 2022 summer programming. With a tagline, "You Belong Here" we have set ourselves to become the number one summer camp in Saskatchewan.



#### **CO-OPERATIVE YOUTH RETREAT**

#### MY BLUEPRINT

This year, SCA partnered up with several other provincial and territorial co-operative associations to develop a co-operative education publication and scholarship program in the online MyBlueprint platform. Every school division in Saskatchewan has access to this platform, which is used by students and teachers to help

youth assess their career path options, track their progress, and figure out what education and training they will need to follow their desired career path.

Through this pilot of using My Blueprint to share co-operative information with high school students, we were able to reach over 6,000 high school students in Saskatchewan in 2021! Over

400 Saskatchewan students submitted applications for 1 of 2 \$500 scholarships, and we were pleased to award these 2 scholarships to students from Pangman and Ituna! We look forward to seeing the next cohort of scholarship applications in the spring of 2022!

#### FROM OUR 2021 SCHOLARSHIP RECIPIENTS:

"Today, many young people feel powerless in a society that is run by power and money. Co-operatives offer a solution to this by giving the youth a voice that will be respected and heard. Co-operatives are unique and different from typical businesses in many ways. 



SCA's Executive Director was also interviewed in June on All for Each - Co-op Radio. The interview focused on youth programming, day camps, youth engagement in co-ops, and Truth and Reconciliation with co-ops and credit unions.

As mentioned in the Co-op Week activities, we worked with Planet S/Prairie Dog again this year on an 8 page feature.

Co-operatives are providing their ideas and feedback, and a process to discuss and align feedback and requests is in progress.

The research will be completed in the summer of 2022, to help inform the Saskatchewan Co-op Act updating process.

# **CO-OPERATIVE** DEVELOPMENT

In 2021-22, we received 27 co-operative development inquiries for the year, down slightly from last year's inquiries (Chart 5). As you can see from Chart 6, the number of co-operative incorporations in Saskatchewan decreased to 6 co-operatives incorporated during the year, versus 10 the year before. The incorporations included a grocery store, individual and family services, childcare, bookkeeping, educational support, and community housing.





Chart 6. Number of Co-operative Incorporations in Saskatchewan


# HAND IN HAND VOLUMES 1 & 2


We were thrilled to launch our new co-op education materials for Newcomers series – Hand in Hand.

We have been providing copies of these resources to Newcomer agencies free of charge, and posted them on our website.



# Purpose of the Organization

The Saskatchewan Co-operative Association is a not for profit organization whose purpose is to develop and promote the co-operative movement in Saskatchewan. The Association is incorporated under the Co-operatives Act of Saskatchewan. Under Section 149 of the Income Tax Act the Association is not subject to income tax.

## 2. Summary of Significant Accounting Policies

The financial statements have been prepared in accordance with Canadian generally accepted accounting principles and, in the management's opinion, have been properly prepared within reasonable limits of materiality and within the framework of the significant accounting policies summarized below.

## Revenue Recognition

The Association follows the deferral method of accounting for revenue. These restricted contributions are recognized as revenue of the appropriate fund in the year in which related expenses are incurred. Please refer to note 7 for a two-year comparison and breakdown of the sources of these revenues.

#### Internally Restricted Net Assets

On October 16, 2018 the Board Of Directors elected to designate some of the reserve funds to guard the organization against possible risks and contingencies. While there are presently insufficient reserves to meet the initial targets of \$430,000, the term deposits have been used for this purpose. Accordingly the value of the term deposits have been extracted from Retained Earnings and attributed to the Internally Restricted Reserve.

#### Capital Assets

Capital assets are recorded at cost. They have been amortized on a declining balance basis at the following rates except in the year of purchase when the rate is reduced by half.
